Opening

The meeting of the Department Chairs' Council was called to order at 4:00 p.m. by Associate Provost Brown-Guillory. She moved that the minutes from the previous meeting be approved. Dr. Needha Boutté-Queen motioned to approve the minutes; it was seconded by Dr. Zahid Iqbal.

Office Administrator to Associate Provost Brown-Guillory

A. Report on the Quality Enhancement Plan (QEP)

• Prof. Arbolina Jennings, Associate Director of the Quality Enhancement Plan (QEP) and Co-Chair of the General Education Subcommittee, gave the council a short overview of the QEP Impact Report for December 2012 and reviewed the Core Curriculum Course Proposal.

- B. Report from the Faculty Senate
 - Dr. Vera Walker Hawkins, Vice Chair of the Faculty Senate, began by inviting the council to the Faculty Senate Holiday Luncheon then reminded council members that senate meetings are the first Thursday of every month. She said all faculty were welcome to come and share their concerns. Dr. Walker Hawkins also spoke about low-producing programs as they related to student failure rates. She also spoke briefly about faculty equity and merit pay raises.
- C. Plagiarism
 - Dr. Michael Berryhill spoke to the council about the university's academic honesty policy, specifically the section stating that students who are found guilty of academic dishonesty are to be brought up directly before the Vice President of Student Affairs. He asked the council if they thought there needed to be a core group that would bring the process back to Academic Affairs. Council members spoke about the processes in their colleges/schools and offered advice.
- D. Advising
 - Dr. Brown-Guillory spoke to the council about the importance of advising and the role it plays in other aspects of Academic Affairs, particularly student retention and graduation rates. She reminded council members that the Texas Higher Education Coordinating Board (THECB) had made advising a priority for the coming year and would be devising an advising assessment tool.
- E. Departmental Meetings with Provost Ohia and President Rudley
 - Dr. Brown-Guillory asked the council how their meetings with the provost and president were going. Council members reported that the meetings had been very productive.
- F. Discussion of Midterm reports and Plan of Action for Student's with All F's
 - Dr. Brown-Guillory encouraged department chairs to ensure that their faculty members submit midterm grades; follow up with students who are performing poorly and contact students with all F's to schedule appointments to discuss ways to help them succeed.
- G. Commencement
 - Dr. Brown-Guillory informed the council that there had been some major changes made to the commencement ceremony and urged council members to attend the December 12th rehearsal in the TSU H&PE Arena at 2 p.m.
- H. Book Orders
 - Dr. Brown-Guillory asked the council to contact the TSU Bookstore Manager, Mr. James Burch, to order books or to make corrections to Mr. Burch's report if books have been ordered.
- I. Opening Faculty Meeting
 - Dr. Brown-Guillory announced the date of Spring Opening Faculty Meeting as Thursday, January 10, 2013. The meeting is to be held in the Barbara Jordan-Mickey Leland School of Public Affairs Building in the McCoy Auditorium, R114, from 8 a.m. to noon.
- J. Faculty Excellence Awards

- Dr. Brown-Guillory reminded the council of the upcoming Faculty Excellence Awards submission deadline dates, March 1st and March 18th. She also announced the dates of the 2012-2013 Faculty Excellence Awards Ceremony and Luncheon to be held Thursday, April 25th.
- J. Faculty Performance Evaluations and Student Evaluations of Faculty
 - Dr. Brown-Guillory informed the council of the progress being made by the Ad Hoc Committees on Faculty Performance Self Evaluation Instrument and the Student Evaluation of Teaching Instrument saying that OIT and the Office of Testing were currently working together to update the Class Climate Software and would have the new online student and faculty forms ready for Fall 2013. Dr. Brown-Guillory asked the council to continue using the old instruments until the online system was up and running. She noted that the committees have representation from each college/school.
- K. University Curriculum Council (UCC)
 - Dr. Brown-Guillory reminded the council that the UCC meets once a month (the third Wednesday of every month) to review proposals and asked that council members continue to work with faculty in their departments to make sure all proposals are submitted through the proper channels.
- L. Low-Producing Programs
 - Dr. Brown-Guillory spoke about the link between low-producing programs, and advising.
