NINETEEN SCHOLARSHIPS AWARDED FOR 2022-2023 ACADEMIC YEAR

BJ-ML School of Public Affairs awarded nineteen (19) scholarships to its majors to help support their studies during the academic year 2022-2023. Nine (9) awards were made based on merit (grade point average), and ten (10) were need-based. Each merit-based awardee received \$1,000.00 and need-based \$500.00. The recipients consist of nine (9) undergraduates, and ten (10) graduate students.

53RD ANNUAL CONFERENCE OF THE LIBERIAN STUDIES ASSOCIATION

BJ-ML School of Public Affairs hosted the 53rd Annual Conference of the Liberian Studies Association from April 23-25, 2022 (Virtually). The conference commenced with an opening session during which US Representative Sheila Jackson Lee brought greetings, and Dr. Muna Ndulo—the William Nelson Cromwell Professor of International & Comparative Law, and the Elizabeth and Arthur Reich Director, Leo and Arvilla Berger International Legal Studies Program, Cornell Law School—delivered the Keynote Address on *Africa Continental Free Trade Agreement: Promises and Perils*.

The subsequent sessions of the conference focused on the presentation of papers on various topics related to Liberia, as well as two roundtables on the scholarship of two distinguished Liberianists—**Dr. Amos Sawyer**, former President of the Interim Government of Liberia, former Dean of the College of Humanities and Social Sciences at the University of Liberia, and former Professor of Political Science at Indiana University, and **Dr. Yekutiel Gershoni**, Professor of History, Tel Aviv University, Israel, who passed away prior to the conference. The Liberian Studies Association, established in 1968, is the second oldest academic association devoted to the study of Africa in the United States.

SYMPOSIUM ON LIBERIA'S BICENTENNIAL CELEBRATION

On February 26, 2022 the School of Public Affairs co-sponsored a symposium on *Land of Return: Liberia*, in honor of Liberia's bicentennial celebration in recognition of the return of African Americans beginning in 1822, and Black History Month. 
