The National Journal of Urban Education and Practice is a national, peer reviewed journal. The Journal seeks to make available educational research and knowledge that will equip and empower educators nationwide with methodologies and research driven tools that will contribute to their ability to meet the diverse needs of urban populations. The Journal is committed to providing literature and resources that contribute to the building of urban professionals that are caring, committed and culturally responsive.

The Journal publishes conceptual and empirical articles that contribute new knowledge and ideas in the quest for excellence in educating urban learners. Each issue has thematic and general interest articles with periodic interviews, and/or book reviews. Graduate students must submit their manuscript with a major professor as co-author.

Manuscripts submitted to the Journal are anonymously reviewed by at least two or more referees unless they are clearly inappropriate due to length, style, or topic. The editors will not return manuscripts that do not meet submission requirements. Articles are judged for:

- Significance to the field of education;
- Comprehensiveness of the literature review;
- Quality of writing, clarity, and organization;
- Significance of conclusions and implications for future research, practice, or policy;
- Adequacy of the rationale and appropriateness of the design and analysis.

The Journal reserves the right to make changes in all manuscripts to improve clarity, to conform to style, to correct grammar, and to fit available space. However, submissions that clearly exceed the space limitations will not be considered.

MANUSCRIPT ACCEPTANCE POLICY: Notification of manuscript disposition may take several months. Accepted articles will not be published until the editors receive the copyright waiver from the author(s). A waiver form is sent to the author(s) with notification of acceptance for publication.

SUBMISSION REQUIREMENTS

GENERAL ARTICLES AND RESEARCH MANUSCRIPTS: Authors must email the manuscript to centerforexcellence@tsu.edu. Authors are to send an electronic, complete MSWord copy of their manuscript to Dr. Bernnell Peltier-Glaze, **Editor**, The National Journal of Urban Education and Practice, email address, centerforexcellence@tsu.edu

I. The editor will submit manuscripts to blind review; therefore, authors/writers should exclude authors' names and institutions and any clues to the author's identities directly on the manuscript. Include names institutions and contact information on **cover page**, only.

II. **LENGTH:** The manuscript, including all references, tables, and figures should be at least 20 pages, but should not exceed 25 pages. Authors should keep tables and figures to a minimum and include them at the end of the text.

III. **TYPING:** All text, including title, heading, references, quotations, figure captions, and tables must be typed DOUBLE- SPACED with one-inch margins all around - Times New Roman, 12 point font required.

IV. **STYLE:** For writing and editorial style, authors must follow directions in the Publication Manual of the American Psychological Association (2009, 6th Ed.)

V. **ABSTRACT:** Abstracts describing the essence of the manuscript must be 120 words or less and typed DOUBLE-SPACED on a separate sheet.

VI. **COVER PAGE:** Authors must include their names, titles, institutions, mailing addresses, home and work phone numbers, fax numbers and e-mail address and a brief (10 words or fewer) description of their areas of specialization.

VII. **BOOK REVIEWS:** Reviews should not exceed 12 DOUBLE-SPACED, typed pages and include city, state, publisher and the year of the book's publication.

IX. UNDER NO CIRCUMSTANCES WILL ANY MANUSCRIPT BE CONSIDERED UNLESS AUTHOR FULFILLS ALL SUBMISSION REQUIREMENTS.
