



The Kase and Eileen Lawal Endowed Scholarship \$7,500 in Scholarship Awards Available 3 - \$2,500 Scholarships Available for Undergraduate and Graduate Students for the Spring 2024 Semester

Scholarship Information:

The Jesse H. Jones School of Business is pleased to present the prestigious and highly competitive Kase and Eileen Lawal Endowed Scholarship opportunity to business students with an interest in international business and global trade. **The scholarship is matched by the President's Leadership Scholarship (PLS), allowing scholarship recipients to receive a \$2,500 Lawal award, in addition to a \$1,000 PLS award.** Scholarship review will occur in the Fall 2023 Semester and awards will be distributed to recipients' TSU student accounts in the Spring 2024 Semester. The scholarship is renewable.

Scholarship Eligibility Criteria:

- Must be classified as a junior, senior, or graduate student in good standing, including transfer credits;
- Must be an accounting, finance, management, MIS, or marketing major (undergraduate) or graduate MBA or MS in MIS student;
- Must be enrolled full-time (undergraduate; minimum of 12 semester credit hours) and (graduate; minimum of 9 semester credit hours);
- Must have achieved an overall grade point average of 3.5 or better;
- MBA and MS in MIS students must have unconditional admission status; and
- Must have completed the Free Application for Federal Student Aid (FAFSA) online or completed and filed the Texas Application for State Financial Aid (TASFA) form (for Non-U.S. Citizens/Texas residents) with the Office of Financial Aid, as required of all scholarship recipients by the University.

Scholarship Application Requirements:

- Completed Electronic Application (with ALL attachments).
- Demonstrated Coursework – Official transcript(s) from all colleges/universities attended (*excludes Texas Southern University*) – **Official transcripts may be sent electronically from the National Student Clearinghouse, sent electronically or mailed from the Registrar's Office, or hand delivered in a sealed envelope.**
- Short Essay – 500-word, double-spaced essay describing your interest in international business and global trade as a career focus.
- One Letter of Recommendation from a current or recent professor, student affairs staff, or employer.
- Professional Resume'
- Professional Headshot (color) in business attire

*****Kase and Eileen Lawal Scholarships are awarded without regard to race, sex, age, national origin, or sexual orientation.*****

The scholarship award will be used to cover tuition, fees, and related costs.

Lawal Endowed Scholarship application will re-open in Fall 2023.
