

WHICH OF THE FOLLOWING DESCRIBES YOUR PRIMARY APPOINTMENT?












FUNDING STATUS BY COLLEGE/DEPARTMENT















USE OF FACILITIES BY COLLEGE/DEPARTMENT





DO YOU HAVE ALL OF THE SERVICES AND INSTRUMENTATION WE NEED?





DO YOU FEEL THE LIBRARY HAS ADEQUATE CONTENT FOR YOUR RESEARCH?







Does the library have adequate content for your research?






PLEASE RATE YOUR LEVEL OF SATISFACTION WITH THE LIBRARY COLLECTIONS YOU MAY HAVE USED?






