

Summer I 2018 Drop/Withdrawal Refund Schedule

Drops (Continued Enrollment)

Any student who drops courses within the first four (4) days of a Summer term and remains enrolled in the University will receive refunds applicable to tuition and fees paid for those courses.

On or before the fourth class day	On or before Thursday, June 07, 2018	100%
After the fourth class day	After Thursday, June 07, 2018	0%

Withdrawals (Discontinued Enrollment)

Any student who officially withdraws from the University will receive a refund calculated according to the following percentage schedule:

Prior to the first class day	Before Monday, June 4, 2018	100%
During the first, second, or third class day	On or before Wednesday, June 6, 2018	80%
During the fourth, fifth, or sixth class day	On or before Tuesday, June 12, 2018	50%
On the seventh class day and thereafter	On or after Wednesday, June 13, 2018	0%

Refundable fees include tuition and designated tuition only.

REGULATIONS GOVERNING REFUNDS

Refunds are granted for those fees designated as "refundable". The refundable fees assessed at registration are tuition and the designated tuition fee. These fees are calculated based upon the number of semester credit hours for which a student registers. Refunds of refundable fees are calculated based upon the total amount of fees assessed at registration and not on the basis of the amount of the payment, if a student is paying on an installment basis.

DROPPED COURSES

Any student who drops courses within the first twelve (12) days of a Fall or Spring semester or within the first four (4) days of a Summer term and remains enrolled in the University will receive refunds applicable to tuition paid for those courses.

Withdrawals (Discontinued Enrollment)

Any student who officially withdraws from the University will receive a refund calculated according to the following percentage schedule:

Prior to the first class day	Before Monday, July 9, 2018	100%
During the first, second, or third class day	On or before Wednesday, July 11, 2018	80%
During the fourth, fifth, or sixth class day	On or before Tuesday, July 17, 2018	50%
On the seventh class day and thereafter	On or after Wednesday, July 18, 2018	0%

Refundable fees include tuition and designated tuition only.

Prior to the first class day	Before Monday, August 27, 2018	100%
During the first class week	On or before Friday, August 31, 2018	80%
During the second class week	On or before Friday, September 7, 2018	70%
During the third class week	On or before Friday, September 14, 2018	50%
During the fourth class week	On or before Friday, September 21, 2018	25%
After the fourth class week	After Friday, September 21, 2018	0%

Prior to the first class day	Before Tuesday, January 22, 2019	100%
During the first class week	On or before Friday January 25, 2019	80%
During the second class week	On or before Friday, February 1, 2019	70%
During the third class week	On or before Friday, February 8, 2019	50%
During the fourth class week	On or before Friday, February 15, 2019	25%
After the fourth class week	After Friday, February 15, 2019	0%
