### Summer 2019 – Information and Instructions Priority Deadline April 30<sup>th</sup>

The summer term is the final term in the academic year at Texas Southern University. Therefore, if a student has completed the FAFSA for the academic year, the application also includes the summer 2019. Students enrolled for summer courses will be evaluated for summer aid by the Office of Student Financial Assistance starting the end of April.

- Submitting an application does not guarantee the availability of aid.
- Every effort will be made to award the student during initial awarding or a reallocation of funds until the **final date of the term**.
- Your summer application will remain active until you submit a written request to cancel your application to the Office of Student Financial Assistance.
- Students failing to officially withdraw from the university and receiving a payment are otherwise considered enrolled unless reported as non-attending by the instructor.
- Students withdrawing after the first class day are subject to a withdrawal calculation to determine how much aid was earned by the student and how much aid must be returned to the Title IV programs.
- Students may only receive payment for repeating the same course in which they receive a passing grade for two instances; the third instance will not be payable through Title IV aid.
- The cost of attendance will be adjusted to reflect the actual hours of enrollment after the 5th class day. Students whose total enrollment is less than the total number of projected hours may owe a refund of aid to the federal programs. Students must monitor their enrollment and account to determine if a payment is required. All payments are due and payable on demand; however, students are encouraged to contact the Student Accounting Office for payment arrangements and due dates.

### A. Am I Eligible for a Pell Grant during the Summer Term(s)?

## NEW YEAR ROUND FEDERAL PELL GRANT

Students who attended Texas Southern University for the fall and/or spring term and completed the semester with satisfactory academic progress may be eligible for an additional payment from the Federal Pell Grant Program for the summer. Simply enroll and complete a minimum of 6 hours to access the additional "year round" Pell payment. The year round Pell will be cancelled if the student fails to complete 6 hours for the term.

#### TRADITIONAL FEDERAL PELL GRANT

 Students who attended less than full-time (12 credit hours) for each session in the fall and/or spring terms may also qualify for a prorated portion of the Federal Pell Grant for the summer term(s).

Students submitting a summer financial aid application are automatically considered for all available grant assistance.

Federal Pell Grant is unlimited, additional grant are limited aid awarded on first-come, first serve basis.

#### B. Am I Eligible for a Federal Direct Loan for the Summer?

Loans for the summer sessions will not be forwarded to the U.S. Department of Education for processing until *the student* has registered for summer classes. Students must be enrolled at least half-time based on their academic level and standing.

#### Federal Graduate PLUS Loan - What is the Federal Direct PLUS Loan Program

The Federal Direct Graduate Plus Loan is a low-interest loan borrowed directly from the federal government. The lender is the U.S. Department of Education. The student must be officially admitted into a graduate program (Master's or Doctoral) at Texas Southern University to qualify to apply for the Federal Direct Graduate Plus Loan program. Parents of unconditionally admitted dependent students are allowed on behalf of students attending as least half-time. The dependent student must submit a summer application for consideration of a Federal Direct Parent PLUS Loan for the summer terms.

### **STEPS**

- Submit the Free Application for Federal Student Aid (FAFSA) at www.fafsa.ed.gov
- Submit supporting documentation directly to the TSU Office of Student Financial Assistance.
- Accept the Federal Direct Plus Loan on MyTSU web portal under Account Summary by Term. Note: This
  does not mean the loan has been approved.
- Complete the credit review at <a href="https://.studentloans.gov">https://.studentloans.gov</a> and not have an adverse credit history.
- Select Complete the Request Direct Plus Process..
  - Select "Apply for Direct Plus Loan."
  - Select the type of PLUS loan
    - Direct Graduate Plus Loan for Graduate Student
    - Direct Parent Plus Loan for Undergraduate Student.
  - Review results of credit review
- If the Federal PLUS Loan is approved, the applicant will be directed to complete the Master Promissory Note (MPN) online process at https://studentloans.gov. PLUS loan awards with a negative credit response are no longer valid awards. The PLUS loan will be cancelled unless the borrower obtains a valid co-signer or successfully appeals the credit denial.. Print and retain the copy of the MPN for your records.
- TSU Office of Student Financial Assistance will certify the loan within 5 working days
- The PLUS borrower will receive a disclosure statement from the U.S. Department of Education
- An electronic confirmation is returned to TSU allowing the funds to be posted to the student's account
- If the student has funds in excess of the outstanding allowable charges on their TSU account, the excess funds are refunded to student within 14 working days.
