Call to Order

Senate Chair Jafus Kenyatta Cavil called the February 2018 monthly meeting of the TSU Faculty Senate to order at 3:04 p.m. on Thursday, February 1, 2018.

Approval of the December 2017 Senate Meeting Minutes

The minutes from the December 4, 2017 meeting were reviewed, and Faculty Senate Chair Jafus Kenyatta Cavil called for a motion to approve the minutes. Senator Lucy Ojode stated that she was not notified and unaware that she nominated to serve as a member of the Faculty Senate. Senator Lacey Reynolds motioned to approved the minutes to include this modification. The minutes were seconded by Senator Claire Thoreson. The motion carried unanimously with no opposing votes.

Status Reports from the Faculty Senate

University Committees Update: An updated report will be submitted to the Senate at a later date. Senator Yousefipour asked if the committees could have an orientation. Senate Chair Cavil asked for feedback and suggestions on orientation. Vice Chair Wu recommended that the chairs of each committee should be responsible for providing orientation.

Announcements from the Chair

Senate Chair Jafus Kenyatta Cavil: Provided an overview of reports discussed during the 2018 Board of Regents Retreat.

Guests

President Austin Lane: Provided an overview of the various university plans, initiatives, and objectives coming within the next year. He discussed such topics as, campus master plan way finder project, the Board of Retreat, current enrollment, persistence rates, graduation rates, the capital expenditure plan. Additionally, he provided updates on the status of his cabinet members, plans for State of the University in May, and the forthcoming cultural exercises which intends to cultivate cultural service, respect, and collegiality on campus were also shared with the Senate. Furthermore, he announced that the Salary Survey via CUPA data was completed in the fall, and plans for a new billboard "Heart and Soul" campaign around Houston is in the developing stages and recruitment strategies. He explained that the university has received great gains in some key areas and other areas still require additional work. Finally, he thanked members of faculty and the Faculty Senate. Vice Chair Edieth Wu: Raised the matters surrounding the gender issues on campus. Additionally, she highlighted the gross problems

relating to female faculty salaries, which must be addressed immediately and communicated to. President Lane responded by stating that his administration is working on the next phase and assess and look at gender, salary inequities, etc. he stated that, however, the enrollment has to be generated in order to address some of these issues. Other issues discussed, were community outreach to the suburbs, and succession plan for leadership positions within the colleges and schools. Several Senators discussed faculty members' interest in administrative positions. President Lane stated that he would like to see the launch of a mentorship program on campus this spring semester. Additionally, among other notable items discussed were six major action items 1) Committee for the Review of Tenure Faculty Sabbaticals, 2) Salary Committee, 3) Re-launching the Teaching and Learning Excellence Center (TLEC), 4) Committee Tenure Track Mentorship Role (including Leadership Development), 5) Faculty Consideration of Family Enrollment Program and 6) Gender Task Force; the latter is an initiative that is scheduled to launch by March 1, 2018.

Old Business

Several Senators discussed their concerns regarding accusation of impropriety during the SOPA dean search

Several Senators: Remarked and discussed their concerns regarding the accusation of an impropriety during the SOPA deans search committee process. Provost Kendall Harris clarified that the impropriety occurred during the process and not with the committee itself. Additionally, he asserted that the committee did its job. Provost stated that he never intended to single out anyone and he apologizes if any committee member felt accused or offended. Others also discussed that if there are occurrences of actions that are unethical, the committees need to be instructed on what steps should be taken to properly handle this issue. So, that the administration is not immediately involved and solutions can be found

Senators discussed and shared various issues such as salary inequities from their perspectives

Senator Lacey Reynolds: Shared some issues with President Lane and other Senators that need a closer look and need to be addressed such as, incentives for staff to achieve higher degrees, and salary inequities for the dedicated faculty. President Lane responded by declaring that his administration will strategically address these issues in an expeditious manner.

Senator Mammo Woldie: Questioned the salary comparison study that includes institutions in smaller cities and low-cost of living. He added that our institution should be compared to institutions in the larger Houston metropolitan area such as the University of Houston. Ms. Keisha David explained that yes he is correct in his observation, however the report includes institutions that are most comparable to TSU based on their programs and enrollment. Senator Woldie added this is not a good comparison

and that these averages on the report are misleading. Additionally, Senator Woldie commented that although a 2 percent bonus was issued recently; conversely some administrators received raises. President Lane responded that everyone received a 2 percent bonus, however, some positions were vacant and by filling these positions temporary basis, some have received a stipend for performing the job. He stated that no one individual's base salary has increased. Others discussed looking into internal equity instead of looking outside of the campus.

Several Senators: Senators discussed addressing issues at the college-level. Possibly having a consultant visit the colleges specifically to address cultural issues and gender biases. Also, a request was made to President Lane to have meetings with faculty in a casual setting to discuss issues from their perspectives.

Senator Carlos Handy: Since the university will not have the total amount of resources to increase salaries necessary for those faculty that have experienced inequities. Therefore, Senator Handy proposed professorship positions based on quality of teaching not just research. Provost Harris suggested that professors have differing percentages based their discipline and college or schools.

Senator Jeffrey Lowe: Requested that the Teaching and Learning Excellence Center (TLEC) is brought back to campus. Provost Harris responded that he will bring the TLEC program back to campus for tenured and tenure-track professors and seasoned faculty members.

New Business

Senator Mammo Woldie: Motioned to adjourn the meeting. Vice Chair Edieth Wu seconded the motion.
