NOTE 6 - Limited registration course offering. A student **MAY NOT** drop a seminar or clinic after January 9, 2007.

NOTE 7 - Writing sample and resume required. The Criminal Externship requires a clean record!

NOTE 8 - Minimum GPA requirement is 2.50 for state court and 3.0 for federal court.

NOTE 9 - Registration by permission prior to registration (See Dean Mouton)

NOTE 10 - Prerequisite-Federal Income Tax-the limit is 15 students.

NOTE 12 - Cannot take more than one in same semester.

NOTE 14 - **MUST BE TAKEN IN CONJUNCTION WITH (AT THE SAME TIME AS) CRIMINAL , CIVIL , OR ADMINISTRATIVE TRIAL PRACTICE.**

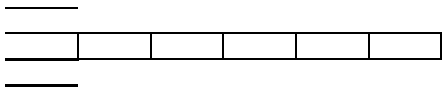
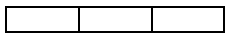
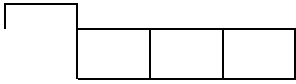
NOTE 15 - Must be enrolled in one of the live client clinics.
