Approval of the December 6, 2012 Senate Meeting Minutes

The minutes were read and approved.

Faculty Manual Report

Guest from Faculty Assembly, Dr. Dan Adams reported on the Faculty Manual.

- 1) The 2002 version given to the committee is not complete.
 - a. Tenure Review: Would like to avoid 5-year requirement
 - i. Retrospective of last five years if majority satisfactory, then know review required
 - ii. Three-year pre-tenure review: halfway point of tenure track
 - iii. RTSP Advisory Committee / Provost (General objection to the committee)
 - 1. As Layers increase, redirects chances of faculty who has been denied to prevail
 - Senator Chair Rasoul Saneifard will ask committee need motion to undo what has been done
 - 3. Can be reconsidered if motion made to committee
 - 4. Provost wanted the RTSP committee to become administrators and then wanted a separate committee
 - b. Discussion of Issue

NOTE: Faculty Manual Committee to remove RTSP advisory committee from faculty manual

- Q: Senator Masoomeh Khosrovani, Does Provost (Dr. Ohia) review dossiers?
- A: Provost Ohia, Yes, I read all dossiers and Associate Provost also reads all of them and they have a discussion. Provost meets candidates who have been denied to meet with Dean and Provost and contacts all persons who have been denied.
- Q: Which manual is used?
- A: Provost Ohia, 2002 Manual. New guidelines are applicable to new employees. New guidelines must be approved by University RTSP committee. Faculty in College academic unit must approve guidelines then the RTSP committee and Provost must also approve.
- Q: Senator Sharlette A. Kellum, Can motion be made not to change faculty manual?

Motion: Senator Daniel Georges-Abeyie, Recommendation that this committee should be removed from faculty manual. Vote \sim Yes = 11, No = 5, Abstain = 1, Motion carries and Dr. Adams will take it to the Faculty Manual Committee.
